CHARITABLE GIFT ANNUITIES AS A LIFE INCOME SOURCE

Have you considered establishing a Charitable Gift Annuity (CGA) as an income source and to reduce your tax liability while helping the Terwilliger Plaza Foundation or the Lesta Hoel Fund? A charitable gift annuity is a contract under which a charity, in return for a transfer of cash or other property, agrees to pay a fixed sum of money for a period measured by one or two lives. The maximum number of annuitants is one individual or one joint annuity.

Payments are made on a quarterly basis. The payment received can be significant. For example, the annual payout rate for an 84 year old woman creating a \$10,000 annuity would be 7.9 percent and result in an annual payment of \$790.00, most of which is tax free. You can use an outright cash gift or a gift of appreciated stock to fund the annuity. The Foundation and Fund have many donors enjoying these benefits.
